Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of April, 2023.

A Memorandum of Settlement (MoS) has been signed on 27.04.2023 between Government of India, Government of Assam and representatives of Dimasa National Liberation Army /Dimasa Peoples' Supreme Council (DNLA /DPSC) of Assam to end the insurgency in Dima Hasao District of Assam. Hon'ble Union Home Minister presided over the signing of this historic agreement. As a result of this agreement, over 168 cadres of DNLA have joined the mainstream by laying down their arms. As per MoS, a Special Development Package of Rs.1,000 crore over five years will be provided by Govt. of India and Govt. of Assam for all round development of NCHAC as well as Dimasa people residing in other parts of the State.

2. A historic Agreement was signed at New Delhi on 20.04.2023 by the Chief Minister of Assam and the Chief Minister of Arunachal Pradesh to settle the longpending inter-state border dispute between Assam and Arunachal Pradesh in respect of 123 villages. Hon'ble Union Home Minister presided over the signing of this historic agreement. Both States have agreed that this agreement will be final with regard to 123 disputed villages and neither of the States will make any new claim related to any area or village in future.

3. A Meeting between Hon'ble MoS, Shri Nityanand Rai and Hon'ble Minister of Public Secretary of Vietnam was held on 10.04.2023. During the meeting, bilateral security issues as well as cooperation at the Regional and Multilateral forums such as ASEAN and G-20 were discussed.

4. The 5th India- UK Home Affairs Dialogue (HAD) was held on- 12.04.2023. Union Home Secretary led the Indian delegation and the UK delegation was led by Shri Matthew Rycroft, Permanent Secretary, and Home Office. During the meeting both sides reviewed the ongoing cooperation and identified further steps that can be taken to explore opportunities and synergies in advancing cooperation in counter-terrorism, cyber security, drug trafficking, migration, extradition, anti-India activities in UK including Pro-Khalistan Extremism among other issues. India's concerns over the breach of security of Indian High Commission were also emphasized.

5. The ceasefire agreement with National Socialist Council of Nagaland /K-Khango (NSCN / K-Khango) has been extended for one-year w.e.f. 18.04.2023 to 17.04.2024. Ceasefire agreements with NSCN (NK) and NSCN(R) have been extended for a further period of one-year w.e. f. 28.04.2023 to 27.04.2024.

6. Two (2) Meetings were held on 12.04.2023 & 17.04.2023 under the chairmanship of AS(LWE), MHA with Nodal Officers of LWE Affected States, IB & CAPFs under Security Related Expenditure (SRE) Scheme to review the LWE affected districts.

7. A total of Rs.83 lakh released to CAPFs under Assistance to Central Agencies for LWE Management (ACALWEM) Scheme.

8. The Himachal Pradesh Ceiling on Land Holdings (Amendment) Bill, 2021 was assented to by the Hon'ble President of India in April, 2023.

9. Constable (GD) examination will be conducted in 13 regional languages other than Hindi and English. The decision will give impetus to participation of local youth in the CAPFs and encourage regional languages

10. 13th meeting of Standing Committee of the Western Zonal Council was held on 15.04.2023 in Gandhinagar.

11. 1st Negotiation Meeting to discuss the Mutual Legal Assistance Treaty in Criminal Matters was held on 13.04.2023 with Nepal through VC. JS (CIC) attended the meeting along with representatives of Ministry of Law & Justice, CBI, MEA (L&T) & IS.II Division (MHA) from the Indian side..

12. A meeting was taken by Joint Secretary (CS) on 26.04.2023 with the representative of Andhra Pradesh and Telangana to discuss the division of Andhra Bhavan as per the provisions of A.P. Reorganisation Act, 2014.

13. NOC issued for changing the name of "Bagribari Railway Station" as "Mahamaya Railway Station" in Assam and name of revenue village "Kukarwari" as "Ramchandrapur" in Dausa District, Rajasthan.
