Consequent upon operationalization of revised/new heads under Rule 8 of DFPR w.e.f. 01st April, 2023 vide Department of Expenditure, Ministry of Finance Notification dated 12th December, 2022, approval of the Competent authority is hereby conveyed for amendment in the nomenclature of Budget Head items at Sl.No. (1) and Sl.No. (4) of table below para (7) of MHA Order of even number dated 02.01.2018, as per details hereunder :

The threshold limit will, however, not apply to the consumables like toner and cartridge for printer shall be classified under revenue expenditure.</li> <li>b) Information, Computer, Telecommunications (ICT) equipment : It will include procurement of information, computer, telecommunications (ICT) equipment such as computer hardware and telecommunications devices (computer, laptops, projectors etc,) and computer software exceeding the threshold limit of one lakh rupees or 3 years of useful life, either of the two, electromagnetic spectrum which is used in the transmission of sound, data and television.</li> </ul>
