**Subject: 05 days UN pre-SAAT training in respect of officers nominated for UN SAAT 2024-26**


Kindly refer to this Ministry's letter of even number dtd 09.10.2023(Copy enclosed) on the above mentioned subject.

The officers will carry with them 9mm pistol and 50 rounds of 9mm cartridge for firing practice along with a pair of Uniform of respective organization. 
