
2. However, due to subsequent un-availability/unwillingness, they were not deployed. In some cases, UN did not approve their nominations without assigning any reasons.

3. Now two more slots will become available for deployment in the month of December, 2023 in the Mission Abyei (UNISFA). In view of this, it is requested to convey the willingness/availability of the above officers along with the requisite documents(i.e updated EASP, MS-3, HR & vaccinated certificates) for consideration for nominations for the UNISFA.

4. It may further be informed that the panel in which the above officers have been included will expire in February, 2024.
