OFFICE MEMORANDUM

Sub: Enhancement of Delegation of financial powers in respect of 26 items to DsG/Directors of the CAPFs, AR, NSG, IB & NIA –reg.

The undersigned is directed to refer to the subject mentioned above and to state that the proposal regarding "Enhancement of delegation of financial powers in respect of 26 items to DsG/Directors of CAPF, AR, NSG, IB & NIA" was examined in this Ministry in consultation with IFD, MHA.

2. The Competent Authority has accorded approval for "Enhancement of delegation of financial powers in respect of following 26 items to DsG/Directors of CAPF, AR, NSG, IB & NIA" in partial modification of this Ministry's Order No.II-27012/01/2009-PF.I dated 11.09.2009, letter No.II-27012/29/2005-PF-I(Part-I) dated 12.10.2011, order No.11012/02/2009-Fin-I/Prov-I-17 dated 02.01.2018, No.IV-21012/01/MHA/ 2017/Prov-I-917 dated 10.09.2018 and No.II-27012/54/CF.3402152/2017-PF.I dated 21.10.2019, as per details given hereunder:


