Sub: The Eligibility List of DANIPS and Puducherry Police Service (PPS) officers whose names are under zone of consideration for promotion to IPS of Joint AGMUT Cadre (UT Segment) for the Select List 2023.

Sir,

I am directed to inform that Police-I Division, MHA vide letter F.No.I-14011/02(U)/2024-IPS.I (E) dated 01.03.2024 has determined 08 vacancies for the Select List year 2023.

2. In terms of extant provisions under the IPS (Appointment by Promotion) Regulations, 1955, the Committee shall consider the cases of members of State Police Services to be considered for promotion in order of seniority, three times the number of vacancies. Therefore, the cases of 31 officers (including 07 officers for the Select List 2022) for the Select List year 2023 is required to be placed before the Committee for consideration, subject to the exception on ground of age limit, willingness, vigilance status etc.

3. In order to prepare the Common Eligibility List of 31 officers of DANIPS and PPS (Annexure-I), their merit in Civil Service Examination for relevant years together with seniority in JAG-I, JAG-II or the equivalent grade as on 01.01.2023 have been taken into consideration.

4. A copy of the eligibility list (Annexure-I) for the Select List year 2023 is enclosed. It is requested that this letter alongwith Annexure-I may be uploaded on the website of all the segments wherever the officers concerned are working. This document is also being uploaded on the website of the MHA, i.e. https://www.mha.gov.in/en/division_of_mha/Union_Territories_Division/circular.

5. It is requested that if any officer has any objection on **Annexure-I**, the same may please be submitted to the undersigned on or before closing of office hours on 30.06.2024. The objections received in the segment concerned may also please be forwarded along-with comments to the undersigned within same timeframe. The objections received after closing of office hours on 30.06.2024, shall not be entertained.
