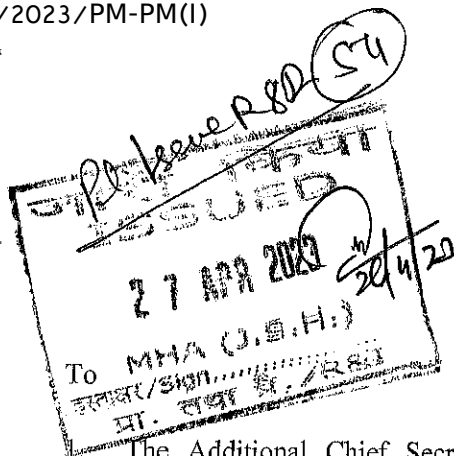
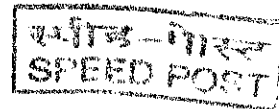

Subject: Submission of Action Plans and Supplementary Plan for the year 2023-24 by the State Governments /UT Administrations under the scheme of 'Assistance to States and UTs for Modernisation of Police'- revised allocations regarding.

Madam / Sir,

I am directed to refer to this Ministry's letter of even number dated 30.11.2022 on the above subject and to convey revised State-wise allocation, as per Annexure, under the scheme of "Assistance to States and UTs for Modernisation of Police". The allocation conveyed has been revised in view of the Budget Estimates approved for the F.Y 2023-24 for the scheme. Total BE for the scheme for the States is Rs. 250 crore and 5% amount, i.e., Rs. 12.50 crore has been kept as Home Minister's Contingency Reserve.

2. The State Governments, which have not submitted State Action Plans(SAPs) till date, are requested that the same may be furnished immediately as per revised allocation immediately. In case of those States which have submitted SAPs, the High Powered Committee will consider/approve their SAPs subject to the reduced allocation and they need not to re-submit revised SAP. However, if they wish, they can furnish revised SAP. It may also be noted that Supplementary Plans need not be submitted as no fund is likely to be released for their implementation in view of the revised guidelines of release of funds under the CSSs.
