**Subject: Compensation to Civilian Victims/Family of Victims affected by Cross Border Firing/Cease fire violation in Jammu and Kashmir from SRE (R&R) reg.**



Sir,

I am directed to refer the issue regarding compensation to Civilian Victims/Family of Victims affected by Cross Border Firing/cease fire violation in Jammu and Kashmir as approved by the Cabinet on 24.08.2016 and to say that following provisions are being made in SRE (R&R) Scheme with the approval of the Competent Authority:-

- (i) Ex-gratia cash relief totaling to Rs. 5 lakh will be given by State Government of J&K to the NoK in case of death or to the victim of more than 50% disability, in their bank accounts, affected by Cross Border Firing/cease fire violation in Jammu and Kashmir.
  - (ii) Ceiling of the above mentioned ex-gratia cash relief of Rs 5 Lakh will include any amount if disbursed to the NoK/victims under the Scheme "Assistance to Civilian Victims of terrorist/ communal/ left wing extremist violence and cross border firing and mine/ IED blast on Indian Territory".
  - (iii) This will be effective from the same date on which the Cabinet has approved the scheme of compensation to the victim of cross border firing i.e. 24.08.2016.
2. This amount may be released to the bank accounts of eligible beneficiaries and the claims may be submitted to this Ministry seeking reimbursement under SRE(R&R).
  3. This issues with the concurrence of IFD vide their Dy. No. 3387449 dated 14.06.2018.


