ORDERS BY THE GOVERNOR
NOTIFICATION

Dated Dispur, the 27th March, 2024

No. HMA-19015/9/2019-Political(A)/Pt-1/93 :: Whereas, the Government of Assam in exercise of powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 (Act 28 of 1958) had declared the areas covering 4 (Four) districts viz. (1) Tinsukia; (2) Dibrugarh; (3) Charaideo; and (4) Sivasagar of the State of Assam as "Disturbed Area" vide notification No. HMA-19015/9/2019-Political(A)/74 dated 27/09/2023 with effect from 01/10/2023 for a period of 6 (six) months;

Whereas, Assam Police Headquarters have submitted a report showing the improvement of Law and Order situation in the state of Assam barring one militant organization being active in 4 districts of Assam viz. Tinsukia, Dibrugarh, Sivasagar and Charaideo and offered views that the imposition of "Disturbed Area" under Armed Forces (Special Powers) Act, 1958 may be continued in the above mentioned districts of Assam beyond 31st March, 2024.

And whereas, Govt. of Assam in Home & Political Department submitted a proposal to this effect to Govt. of India, Ministry of Home Affairs vide this Department's letter No ECF-200043/91 dated 14/03/2024.

And whereas, Ministry of Home Affairs, Govt. of India, after due consideration of the proposal informed the Govt. of Assam vide letter No. 11011/51/2015-NE.V dated 27/03/2024 to maintain "status-quo" regarding "Disturbed Areas" in State of Assam for a further period of six months w.e.f. 01/04/2024.

Now, therefore, in exercise of the powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 and in supersession of earlier Notification vide No. HMA-19015/9/2019-Political(A)/74 dated 27/09/2023, the Governor of Assam is pleased to declare the areas covering 4 (**Four**) districts viz. **(1) Tinsukia; (2) Dibrugarh; (3) Charaideo; and (4) Sivasagar** of the State of Assam as "Disturbed Area" for a further period of 6 (six) months w.e.f. 01/04/2024, unless withdrawn earlier.
