Subject: Revised rates on sale of pups & Trained Dogs from CAPFs Dog Training and Breeding Centres (DT&BCs).

Reference SOP on "Sale of Pups and Trained Dogs from CAPFs Dog Training and Breeding Centres" issued vide this Ministry's U.O. No.A-33025/12/2021-PM-K9Cell (CFN) 3526282)24-42 Dated 14th Jan '2022.

2. The sanction of the Competent Authority is hereby accorded on the proposal for the Revision of the selling price of Pups and Trained Dogs from CAPFs Dog Training & Breeding Centres (DT&BCs), as recommended by the CAPF Board of Officers (BoO) and intimated vide SSB UO No. 236/Vet/SSB/2018/1536 dated 07 Nov' 2024 and No. 236/Vet/SSB/2018/1701 dated 24 Dec' 2024 as under: -

(ii)	Pup at 06 months age	76,000/-	
(iii)	Pup at age 09 months duly trained in Basic/ Tactical Obedience	1,12,000/-	Rs 10,425/-per month be added on account of feeding for delay in collection of pups.
iv)	For Dogs, Where the duration of training is 06 months (Comprising of explosive Detection, Narcotics Detection, Infantry Patrol, Guard, Mine Detection etc. (including cost of Dog Handler during training))	5,96,000/-	-
v)	For dogs, where training period is 09 months (comprising of Search & Rescue, Tracker and Dual Purpose (Patrol Plus Detection) K9s etc. (including cost of Dog Handler during training))	8,55,000/-	-
vi)	For Dogs, Where the duration of training is 06 months (Comprising of explosive Detection, Narcotics Detection, Infantry Patrol, Guard, Mine Detection etc. (excluding cost of Dog Handler))	2,96,000/-	-
vii)	For dogs, where training period is 09 months (comprising of Search & Rescue, Tracker and Dual Purpose (Patrol Plus Detection) K9s etc. (excluding cost of Dog Handler))	4,05,000/-	-

3. The prices of pups and trained dogs will be revised after every three years as proposed by the CAPF Board of Officers, considering escalation in input prices.

4. This issues with the concurrence of IFD of this Ministry and Union Home Secretary vide File No. 99/VET/SSB/2018(CF3423138) dated 22 Jan' 2025 and 06 Feb'2025 respectively.
