Vide order dated 22.03.2025, the Hon'ble Presiding Officer was pleased to observe as follows:

***"Mr. Fernando Shangpilang, Advocate has entered appearance on behalf of Hynniewtrep National Liberation Council (hereinafter referred to as 'HNLC') under the instructions stated to have been issued by the Office bearers of the Organization. He is permitted to file the necessary authority before the Registrar during the course of the day. Subject to the necessary particulars and authority being filed and found to be in order as per the procedure prescribed by law, the Registrar of this Tribunal, after necessary endorsements in the office records to that effect, will ensure that service of copies of the evidence filed on affidavit by the learned Special Counsel and learned counsel for the State of Meghalaya latest by 25.03.2025. If the necessary authority is not filed or not found to be in order by the Registrar, the learned Special Counsel and learned counsel for the State of Meghalaya are not required to serve copies of evidence to the learned counsel for HNLC.***

***Let the process for service of evidence by the Union of India and State of Meghalaya on the learned counsel for HNLC, subject to the terms ordered hereinabove, be completed by 25.03.2025 and an endorsement to that effect be recorded by the Registrar of the Tribunal."***

It may be mentioned that Mr. Fernando Shangpilang, Advocate; did not file the necessary authority before the undersigned in spite of explicit direction by the Hon'ble Tribunal.

As such, the learned Special Counsel for Union of India and learned counsel for the State of Meghalaya are not required to serve copies of evidence to Mr. Fernando Shangpilang, learned

counsel for HNLC in view of his failure to comply with order dated 22.03.2025.

This has the approval of Hon'ble the Presiding Officer.
