The board had assembled to discuss the issue raised by Directorate General, Assam Rifles vide letter No. IV.18081/2024-25/ORD/M&E dated 27th Dec 2024 regarding difficulties being faced in obtaining the requisite lab test certificate/ report against parameter "Life of Barrel" in SI. No. 18 of the QRs/TDs by the vendors during the procurement process of Multi Grenade Launcher (MGL) 40 mm.

2. Directorate General, Assam Rifles intimated that as per MHA QRs/ TDs of 40MM MGL, lab test certificate/ report in respect of '**Life of Barrel**' is required. Hence, issues are being faced in obtaining the requisite lab test certificate / report for life of barrel by the vendors. As per inputs received from various labs (including TBRL, NFSU, DLIC (DRDO) and NABL)/ vendors during the meeting of Board of Officers conducted on 05th Mar 2025, it is learned that **there are no NABL labs in India which are capable of undertaking test for 'Life of Barrel'**.

3. As per MHA approved QRs/ TDs promulgated vide NSG letter No P/604/389/2024/MGL (40MM)/Prov(Ord)/HQ NSG/E-108018/1266 dated 03 Jul 2024, specification and TDs of the parameter 'Life of Barrel' are as under: -

4. The board had carried out detailed discussion on the above issue. After exhaustive deliberation, the members of the board opined to amend the existing TDs in SI. No. 18 of the QRs/TDs of Multi Grenade Launcher (MGL) 40 mm as under: -


RECOMMENDATION OF BOARD OF OFFICERS






