**Subsidized Helicopter Services:** In order to provide connectivity to some areas in Jammu and Kashmir and Himachal Pradesh, which are remote, inaccessible by road or even when connected by road remain cut off during winter due to rain / snowfall, a Scheme of Subsidized helicopter services in J&K and Himachal Pradesh for 10 inaccessible sectors in each State was approved on 06.09.2016, on pilot basis with subsidy by the Government of India upto 75% of the operational cost after deducting flat 20% on account of passenger recovery or actual recovery, whichever is more. The Scheme has been extended till 2025-26 in UT of J&K, UT of Ladakh and Himachal Pradesh on 6, 7 and 10 approved routes respectively. The scheme is not operational in HP at present.

Sir,

I am directed to refer to this Ministry's letter of even number dated 14.8.2020 conveying approval of interim extension /continuation of subsidized helicopter services in UT of J&K for the period from 1.4.2020 to 31.3.2021. The Competent Authority has now accorded its approval for continuation of helicopter services in UT of J&K in five routes for the period from 2021-22 to 2025-26 i.e. from 1.4.2021 to 31.3.2026.

(i) Five approved routes for operation of helicopter services in UT of J&K are as under:



- (x) The operation of helicopter services in the Union Territory will continue till 31.3.2026.

The Competent Authority has now accorded its approval for continuation of helicopter services in Himachal Pradesh in ten routes for the period from 2021-22 to 2025-26 i.e. from 1.4.2021 to 31.3.2026.


