Subject:- Enhancement of Ex-gratia Relief of the J&K Police Personnel killed in course of performing duties attributed to act of violence.

Sir,

I am directed to refer to Home Dept. Govt. of J&K's order No.1046-GAD of 2017 dated 10.08.2017 and to state that the Ex-Gratia Relief was Enhanced by Home Dept., Govt. of J&K from Rs.7 lakh (Rupees Seven Lakh) to Rs.20 lakh (Rupees Twenty Lakh) which comprises of Rs.18 lakh of State Govt. share and Rs.2 Lakh of MHA share per case, payable to the Next of kin (NoK) of the J&K Police Personnel killed in violence/militancy related incidents in the State.

2. Considering the long pending demand for enhancement of said Ex-Gratia Relief and to make it at par with the Ex-Gratia Relief being paid to CAPF personnel in cases of death occurring in course of performing duties attributable to act of violence by terrorists, anti social elements etc., the above matter has been considered in the Ministry and it has been decided to enhance the share of Ex-Gratia in the State, paid from Police Welfare fund, MHA as well as from SRE (R&R) as under:-

- (i) MHA will make payment of Rs. 7 Lakhs in place of Rs. 3 Lakh to the NoK of each J&K Police Personnel from the Police Welfare fund. The expenditure is debitable to Major Head 2055- police 00:113 Welfare of Police Personnel (Major Head) 00.00.31-Grant-in-aid Contribution under Grant No. 47-Non Plan. The other terms and conditions for sanction of the amount of Rs. 7

lakhs from Police Welfare Fund would be the same ~~as~~ as per Ministry's letter no. 16016/16/98-K-II dated 17/05/2001 (copy enclosed).

- (ii) MHA will also make payment of Rs.5 lakhs in place of Rs.2 lakhs to Nok of J&K Personnel /SPO's as well as Nok of CAPFs / Army posted in J&K. The expenditure is debitable under Security Related Expenditure (Relief and Rehabilitation). The existing terms and conditions / guidelines for grant of ex-gratia relief from SRE(R&R) of Rs.5 lakhs in place of Rs. 2 lakhs would continue.

3. The total ex-gratia relief payable to Nok's of J&K Police Personnel killed in course of performing duties attributed to act of violence in the State in J&K would be Rs.30 lakhs. The details of funding of Rs.30 Lakhs is as under:-

GoJK (State Budget)	18 Lakhs
MHA (Police Welfare Fund)	7 Lakhs
MHA (J&K, SRE, R&R) through GoJK	5 Lakhs
Total	30 Lakhs
