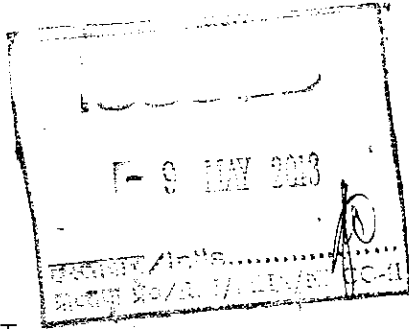

Sir,

With reference to your application dated 21.03.2013 and this Ministry's OM No. A-43020/01/2013-RTI dated 17.04.2013 on the subject mentioned above, it is stated that only point (1) of your request concerns this CPIO.

2. The Ministry of Home Affairs is only administratively concerned with the President's Emoluments and Pension act, 1951 and the rules framed thereunder, which deals with Salary of the President and post retirement benefits for the former Presidents. As per the aforesaid act and rules the Directorate of Estates, Ministry of Urban Development shall be responsible for arranging accommodation for the former President and the surviving spouse. The section under this CPIO has not issued any sanction for relaxation of the rules in respect of living areas for former Presidents.

3. As regards other points, your application is being transferred to the, under Section 6(3) of the RTI Act 2005, to the Directorate of Estate, Ministry of Urban Development for necessary action.

4. As per Section 19 of the Right to Information Act, 2005, an appeal against this letter would lie before Shri S. Suresh Kumar, Joint Secretary (CS) and the First Appellate Authority, Ministry of Home Affairs, NDCC-II Building, Jai Singh Road, New Delhi.
