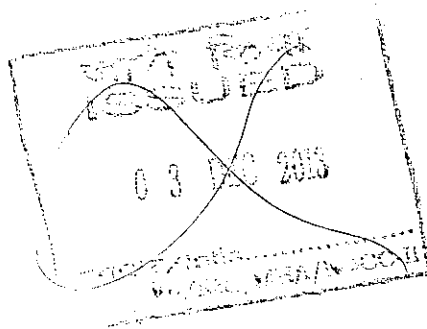

2. The prescribed application fee of Rs. 10/- has been received in this Ministry.



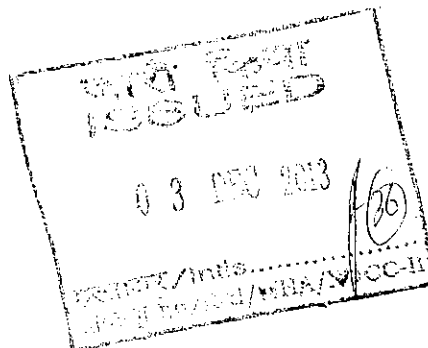

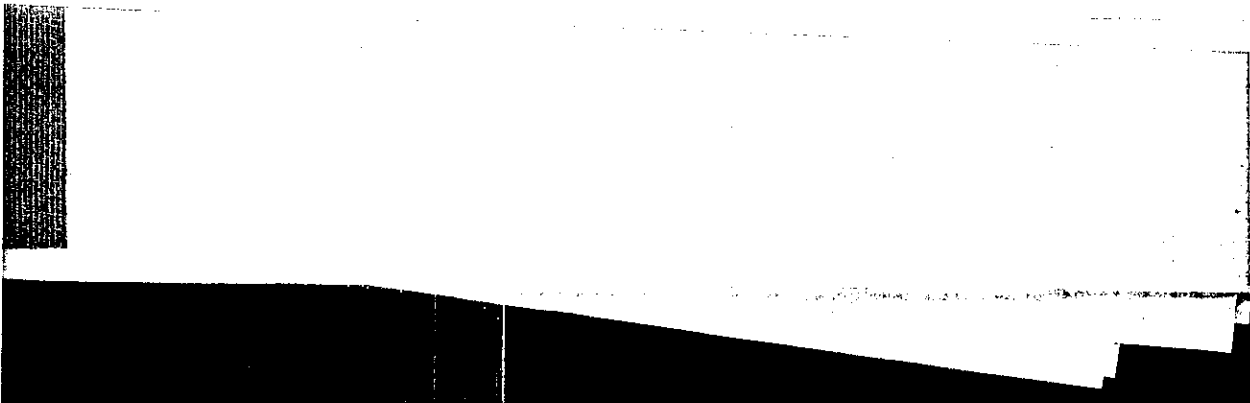


