2. Available information on point no. 4 (E) of the above said application is furnished as under:- -7/c

The State Governments have their own policy for compensation to the families of Civilians and State Police personnel killed in Left Wing Extremist (LWE) violence. However, under the Security Related Expenditure (SRE) Scheme for the LWE affected States, the Central Government, inter-alia, reimburses to the State Governments of 9 LWE affected States viz. Andhra Pradesh, Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Maharashtra, Odisha, Uttar Pradesh and West Bengal, the expenditure incurred for payment of ex-gratia to the family of victims of naxal violence at the rate of Rs. 1 lakh per civilian killed and Rs. 3 lakh per security personnel killed in LWE violence. The details regarding amount of ex-gratia given to the beneficiaries are not maintained centrally by this Division. The information may be had from the respective State Governments.
