

Sir,

This is regarding recent developments in the State regarding demands from certain NGOs and other pressure groups for implementation of Inner Line-Permit in the State.

2. The matter was examined in this Ministry. ILP in the modern context is economically not a viable and sound proposition. The Central Government is assisting the State Governments for the overall economic development including backward region of the State. ILP system after 66 years of Independence would be a retrograde step and would not augur well for the economic development of the State. In any case, legally it will be untenable to introduce.


3. In view of the above, the State Govt. is advised to pacify the agitating groups demanding implementation of ILP in the State.
