1. Complete information on pending requests received for converting government-bungalows at New Delhi, in memorials of departed dignitaries/personalities etc together with copies of such requests and file-notings/correspondence/documents etc made on such requests and replies given on such requests
2. Complete information on rules for converting government-bungalows at New Delhi into memorials mentioning also steps taken for early disposal of pending requests for converting government-bungalows at New Delhi in memorials as per rules
3. List of government-bungalows at New Delhi kept un-allotted for which demand is made to convert in memorials mentioning also period from which these are un-allotted revealing also accumulated rent-loss for each of such un-allotted bungalow
4. Complete information on securing safety, security of such un-allotted government-bungalows at New Delhi mentioning also if some such bungalow has unauthorized structures/encroachments etc providing complete details of such illegal activities
5. Complete information on action taken against (a) encroachers/trespassers/private residents at un-allotted government-bungalows at New Delhi mentioning also if police-complaint is ever lodged in this regard (b) concerned government-employees for not taking action against such encroachments/trespass on such un-allotted government-bungalows at New Delhi
6. Complete information on rules about holding meetings etc at un-allotted government-bungalows by family-members of those having requested for conversion of such bungalows in memorials and/or others mentioning also action taken against trespassers holding such meetings without government-permission like is done twice a year at 6 Krishna Menon Marg (New Delhi)
