2. In the above context, it is informed that there is no provision in the Protection of
Human Rights Act, 1993 to fill up the post of chairperson through category-wise reservation.
However, the section 2(a) of Protection of Human Rights Act, 1993, provides that the
commission shall consist of a Chairperson who has been a Chief Justice of Supreme court and
section 3 of the Act, 1993 provides that the 'Chairpersons of the National Commission for
Minorities, the National Commission for the Scheduled Castes and Scheduled Tribes and the
National Commission for Women shall be deemed to be Members of the Commission for the
discharge of its functions.
