Sir,

Please refer to your RTI application dated 04.08.2013 submitted under the RTI Act, 2005, received by this Section through Webn Portal on 12.08.13.

2. It is informed that the State Government concerned are primarily responsible for undertaking necessary rescue & relief measures in the wake of natural disasters including flash flood/landslide. The distribution of relief on ground is the responsibility of the State Government concerned. The Government of India supplements the efforts of the State Governments by providing financial and logistic support, if required to meet the situation effectively. For this purpose, a State Disaster Response Fund (SDRF) has been constituted with an allocated amount for each State. The State Governments are expected to take relief measures of immediate nature, out of the funds available in the SDRF. State Executive Committee headed by the Chief Secretary is empowered to operate the relief fund and also responsible to ensure that money drawn from the SDRF is actually utilized for the purpose for which the SDRF has been setup, and only on items of expenditure, and as per norms contained in the guidelines issued by the GOI. These items & norms are uploaded on the website of this Ministry [www.ndmindia.in](http://www.ndmindia.in).

3. As per the information received, the State Government has announced ex-gratia to the next of kin of the deceased persons/persons feared to be dead @ Rs.1.50 lakh from State Disaster Response Fund, @ Rs. 1.50 lakh from State Government share, @ Rs. 2.00 lakh from PM Relief Fund per person.


4. Government of India has released an amount of Rs. 145 crore from State Disaster Response Fund on 20<sup>th</sup> June, 2013. In addition, GOI has released an amount of Rs. 250 crore on an 'on account' basis from the National Disaster Response Fund on 19<sup>th</sup> July, 2013.

5. However, information asked under your application is related specific to the State Government of Uttarakhand & Ministry of Defence which is being sent to them for their appropriate action.

6. If you are not satisfied with this reply, you may prefer an appeal under Section 19(1) of the RTI Act, 2005 within thirty days from its receipt to
