This Ministry has received an appeal dated 08.09.2013 from Shri Shyamlal Yada in connection with the information sought through his RTI application dated 31.05.2013 under RTI Act, 2005.

2. Whereas the applicant has preferred above mentioned appeal stating that Minister-wise data in respect of foreign visits of Ministers has not been provided. The CPIO has provided merely the total expenses incurred on foreign visits of Ministers which do not serve my purpose.

3. Whereas, it is stated that this CPIO is concerned with the making of only budgetary provisions for tours of Ministers (both Cabinet and State) as a whole for a financial year. As per procedure sanction are to be issued by the concerned Ministry and bills in respect of such expenses are raised and submitted in Pay & Accounts Office, Cabinet Affairs for payment. Minister-wise data in respect of expenditure on tours of Ministers is not maintained with this office, however, as per statement made available by Pay & Accounts Office (Cabinet), expenditure incurred on foreign visits of Union Ministers in financial year (year-wise) was provided to you (copy enclosed).

4. In view of the above the appeal stands disposed off.
