

- Daily allowance at the rate of Rs.2000/- per day during the whole of his term as Cabinet Minister, w.e.f. 1.10.2010. (***As rule referred above***)
- Constituency Allowance of Rs.45,000/- per month w.e.f. 1.10.2010. (***Ministers Salary and Allowances Act, 1952; Para-2-Extracts from Members of Parliament Constituency Rules, 1986***)
- Sumptuary Allowance of Rs.2,000/- per month (PM is entitled to this allowance at the rate of Rs.3000/- per month). (***Ministers Salary....Act, 1952 Para-5***)
- Travel facility within India for private purposes for himself, any number of companions or relatives and his family members subject to overall entitlement of 48 fares in a calendar year. While the companions or relatives can travel only with Minister, the family members can travel either alone or along with the Minister. (***Ministers Salary....Act, 1952 Para-6(1)(A)***).
- He can travel by both national carriers and private airlines while undertaking official journeys or journeys for private purposes.. (***Ministers Salary.....Rules, 1957, Rule No. 13***)
- He is also entitled to free non-transferable rail pass as admissible to a Member of Parliament.(***Ministers Salary....Rules, 1957***)
- Medical treatment for himself and the members of his family as admissible to the Members of all India Services (***Ministers Salary...Rules, 1957 Rule No. 29***)
- Two constituency telephones at the places of his choice with a total number of 1,00,000 free local calls taken together on both these telephones, in a year which includes 50000 local calls for internet connectivity purposes. (***Refer OM No. 10/16/2000-M&G dated October 6, 2003***)
- Mobile telephone for which Rs.2500/- per month is reimbursed with the cost of the handset limited to Rs.10,000/- (***Refer Department of Expenditure's OM No. 5(1)/E-Cord/2002 dated August 6, 2003***)
- Entitlement to 15 members on his personal staff as per the norms fixed by the Department of Personnel and Training (***DoP&T***)
- Entitlement to Government Accommodation (Type-VIII) to be provided by the Directorate of Estates of the appropriate class. Water and electricity charges in respect of this accommodation are not payable by him. (***Ministers Residence Rules, 1962***)
