

Inviting Ambani family of three generations at Prime Minister's oath taking ceremony:

Who invited them President or oath-taking Prime Minister?

It was surprising to note presence of Kokilaben Ambani together with both her industrial-tycoon sons Mukesh and Anil accompanying their wives and sons at oath-taking ceremony of Prime Minister Narendra Modi at Rashtrapati Bhawan (New Delhi) on 26.05.2014 at a time when list of 4000-odd privileged ones had to be miserly selected out of too many aspirants eager to attend the historic event.

Presence of Mukesh and Anil Ambani could be justified because of their influencing role as India's leading industrialists. But attending oath-taking ceremony of a new-era Prime Minister by all the three generations of extended family of late Dhirubhai Ambani certainly gives wrong signal of Ambanis' influence on India's political and governance system. Authority inviting Ambani family with such importance should be named if it was President Secretariat or oath-taking Prime Minister Narendra Modi.

Absence of Baba Ramdev in oath-taking ceremony of Prime Minister Narendra Modi was significant and should have been avoided. It may be recalled that Rahul Gandhi came under severe criticism for curious absence at farewell-dinner of the then Prime Minister Dr. Manmohansingh hosted by his mother Sonia Gandhi in her capacity as UPA Chairperson. Those in public life need to be careful in ensuring presence at important events.

But giving too much importance to Ambani family by Rashtrapati Bhawan is not proper and needs to be avoided at least for future. Rashtrapati Bhawan should give clarification on over-importance provided to one single (Ambani) family at such important events.
