The brief FACTS of this matter are:-


That the appellant has submitted the above referred on line RTI applications under RTI Act 2005 to the Ministry of home affairs on 26-05-2014 which was transferred to The DG, NDRF, East block-VII, Level-VII, R.K.Puram, sector-1, New Delhi-66 vide Sh.Gautam Ghosh, Deputy Secretary(DM-1)&CPIO letter No.40-8/2014-NDM-1.in which it is informed that Sh.G.V.V.Sharma,JS (DM),Ministry of Home Affairs,' wing, 3rd floor,Jai Singh Road, New Delhi-110001 is the appellate authority (Attached the content of online RTI'S and Forwarding letter from CPIO as Annexure-A&B).Receipts of Online application attached as annexure-C&D

That the "CPIO has not provided any answer of my application till date.

My GROUNDS for the appeal are as follows:

01. According to the RTI Act, if the information as defined under Section 2(f) is not exempt from disclosure under Section 8(1) or 9 of the Act, and is held by a public authority as defined under 2 (h), it has to be disclosed. It is clear that the information sought is information as defined under Section 2(f) of the RTI Act and is held by NDRF, a public authority.

02.Our Constitution establishes a democratic republic. Democracy requires an informed citizenry and transparency of information which is vital to its functioning..The purpose and object of the RTI act is not only to provide information but to keep a check on corruption, and dismal record of misgovernance which colludes to deny Citizens their essential rights and dignity.
