With reference to your 1st Appeal dated 14.06.2013 (received in UTS-I Section ,MHA from US, RTI Cell through Delhi Police for providing reply on point no 2,4,5,8,10 & 12), point wise information as available in UTS-I desk is provided as under:-

- Point No 2: Immovable Property Return (IPR) details of IPS officers can be obtained from the website of Ministry of Home Affairs which can be accessed by directly following the websites link <http://mha.nic.in/ipr/iformain.htm>
- Point No 4: Action can be initiated as per AIS Conduct Rules 1969, for non submission of IPR. Further part of information sought is query which is not covered under RTI Act.
- Point No 5: No, However practice of placing of IPRs in Public Domain is in practice.
- Point No 8, 10 & 12: The information pertains to Delhi Police as internal postings of officers in the Deptt. of Delhi Police are managed by PHQ. MHA is concerned with the allotment of a particular UT/State only. The application is being referred to Delhi Police.

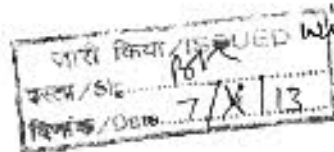

Please refer to your appeal dated 14.06.2013 which was received in this office on 21.06.2013 and directions/order passed by 1st Appellate Authority/Jt.C.P/Hdqs., Delhi vide letter No.24/29/Spl/ID-957/2012/Appeal No. 105-misc./2012/8715-16/RTI/Estt./PHQ dated 19.07.2013, on the subject cited above. As directed, a copy of your 1st appeal is being transferred to The Director & CPIO, Govt. of India, **Ministry of Home Affairs**, North Block, New Delhi for furnishing the requisite information directly to you on the points no. 2, 4, 5, 8, 10 & 12 in respect of officers above Inspectors, as the record of the officers above Inspector is being maintained in MHA. With regard to information in respect of Inspectors the information has already been provided by all the PIOs of Delhi Police. However, on the basis of reports furnished by all the PIOs a consolidated reply is as under :-

2. As per rules Inspectors are not required to file their property return annually. With regard to information in respect of the officers above the rank of Inspectors, it is stated that such record of officers is being maintained by MHA.

4. No specific punishment for the said lapse has been categorized. However, necessary departmental action against the delinquent is taken according to the quantum of the misconduct as per CCS (Conduct) Rules, 1964 and under section 21 of Delhi Police Act, 1978. No departmental action against any Inspector has been intimated in Delhi Police for non submission of property return as no such case has been detected during the last ten years.

5. No, there is no monitoring mechanism to take note of sudden increase in an officers/wealth/properties.

8. A list of police officers, received from RTI Cell/PCR, Room No. 113/114, Addl.DCP/PCR Office Complex, Model Town-II, Delhi-110009 is **enclosed** herewith.

10. The transfer/posting of officers/men is made as per the provision contained in SO No.289. No such training is imparted to the officers/men before their posting in specialized units like Crime Branch, Anti-Corruption Branch, EOW, Vigilance etc. However, from time to time refresher courses are being organized by training branch in PTC.

12. As per record of Web-PIS Database on Intra-DP, the following officers of the rank of ACP and above have been found who were transferred from sensitive to non-sensitive or non-sensitive to sensitive within the month during last two years.
