Subject: Application under RTI Act, 2005- Regarding.

Sir,
With reference to your application dated 04-11-2013 (received in UTS-I section, MHA through Delhi Police on 11-12-2013, the point-wise information relevant to UTS-I & UTS-II Sections is provided as under:

Points 2: The promotion of IPS officers is regulated as per IPS (Appointment by Promotion) Regulations, 1955. Further, the information sought not only pertains to a period falling 20 years back but also involves compilation of voluminous documents, which would disproportionately divert the resources of the public authority. Therefore, it is not possible to provide the information asked for. Further, no such consolidated data is maintained.

Point 3: The direct recruitment of an IPS in ACP is done as per extant Rules.

Point 14: The promotion of DANIPS (incorrectly stated as DANIS by the applicant) officers are regulated as per relevant DANIPS Rules. Further, the information sought not only pertains to a period falling 20 years back but also involves compilation of voluminous documents, which would disproportionately divert the resources of the public authority. Therefore, it is not possible to provide the information asked for. Further, no such consolidated data is maintained.

Point 15: The basic eligibility qualification for appearing in Combined Civil Service Examination is same. However, candidates are selected for appointment to IPS and DANICS as per their ranking/preference etc in the said examination.

Point 16: The information asked for is not clear. However, the power and functions of an ACP do not depend upon his being from IPS or DANIPS

Sub- Application under RTI Act 2005 vide postal order no. HF 113753 about given below facts from

- The office of the Prime Minister of India, Sh. Manmohan Singh ji

- Commissioner of Delhi Police, Sh. BS Bassi ji
- LG of Delhi

- 1) It came to my knowledge that the Delhi police officials, who are recruited directly as Sub Inspector get only 2-3 promotions in their lifetime which are Sub Inspector/Addl. SHO/SHO/ACP
 - a) I want to know the no. of Delhi Police officials who were recruited directly as Sub inspector and retired as SHO in the last 66 years or as per the available record.
 - b) I want to know the no. of Delhi Police officials who were recruited directly as Sub inspector and retired as ACP in the last 66 years or as per the available record.
 - c) I want to know the no. of Delhi Police officials who were recruited directly as Sub inspector and retired as Addl. DCP in the last 66 years or as per the available record.
- 2) It came to my knowledge that the Delhi police officials who are recruited directly as ACP (IPS) get only 5-7 promotions in their lifetime which are ACP/Addl. DCP/DCP/Addl. CP/Jt. CP/Spl. CP/Commissioner
 - a) I want to know the no. of Delhi Police officials who were recruited directly as ACP (IPS) and retired as DCP in the last 66 years or as per the available record.
 - b) I want to know the no. of Delhi Police officials who were recruited directly as ACP (IPS) and retired as Addl. CP in the last 66 years or as per the available record.
 - c) I want to know the no. of Delhi Police officials who were recruited directly as ACP (IPS) and retired as Jt. CP in the last 66 years or as per the available record.
 - d) I want to know the no. of Delhi Police officials who were recruited directly as ACP (IPS) and retired as Spl. CP in the last 66 years or as per the available record.
 - e) I want to know the no. of Delhi Police officials who were recruited directly as ACP (IPS) and retired as Commissioner in the last 66 years or as per the available record.
- 3) I want an explanation for the direct recruitment of an IPS to a minimum rank of ACP from above Govt. Agencies
- 4) I want an explanation from Delhi Police Commissioner for not giving investigation cost to an IO
- 5) I want an explanation from Delhi Police Commissioner for not giving Overtime to a Police official
- 6) I had raised the issue of Shoes allowance which had been stopped from 2011. I had applied several RTIs about this matter in last one year but still the shoes allowance is not being given. In the interest of 83,000 police officials I want an explanation about it from concerned Govt. Agencies
- 7) I had raised the issue of illegal and unsafe Police Booths through several RTIs in last one year. After which some police booths were demolished but new and Safer police Booths have not been provided to them till now. In the interest of 83,000 police officials I want an explanation about it from concerned Govt. Agencies
- 8) The police officials below the rank of Inspector are not given any official mobile phone or SIM card. As a result they are forced to use their personal mobile on Duty for coordinating with other police officials and taking official directions. But this personal mobile no. is can't be provided under the provisions of RTI Act. Therefore I want an explanation from Delhi police and other concerned Govt. agencies about it (not providing mobile allowance and not declaring these personal nos in RTI replies)
- 9) The police officials below the rank of Inspector are not given any official Vehicle. As a result they are forced to use their personal vehicle on Duty for coordinating with other police officials, taking official directions and attending Emergency/100 no. calls. But this personal vehicle no. can't be provided under the provisions of RTI Act. Therefore I want an explanation from Delhi police and other concerned Govt. agencies about it (not providing vehicle allowance and not declaring these personal vehicle nos. in RTI replies)

c. I want to know that has Delhi police issued any guidelines on its website about the spots at which NAMAZ is prayed and the timings of NAMAZ so that general public can avoid this harassment due to traffic jam.

23) I want to know the no. of FIRs registered by Delhi Police against the Doctors/Ultrasound Centers who were doing illegal Gender Determination tests and illegal Female Feticide in the last 66 years or as per the available record

24) I want to know the no. of FIRs registered against concerned police officials who were ignoring Illegal Dhahas/Restaurants and providing shelter to them in the last 66 years or as per the available record

25) I want to know the no. of FIRs registered against concerned police officials who were ignoring Illegal Betting/Satta/Hawala cash business and providing shelter to them in the last 66 years or as per the available record

26) I want to know the no. of FIRs registered against Delhi Police officials for illegal detention of Victim, Accused, Witness or Complainant without making entry in Daily Dairy register in the last 66 years or as per the available record.

a. When a senior police official comes to know of such an offence he only transfers the accused Police official as a punishment instead of registering an FIR. These police officials sometimes get reinstated after some years with same designation. I want an explanation about this from Delhi Police Commissioner and other Govt. Agencies

b. As mentioned in para no. 26(a), I want to know the no. of such cases in which the accused police official was transferred for illegal detention in the last 66 years or as per available record

c. Also No punishment is given to the accused police official for the harassment and illegal recovery he does from the Victim and Victim's Family. I want an explanation about this from Delhi Police Commissioner and other Govt. Agencies

d. As mentioned in para no. 26 (d), I want to know the no. of police officials who were punished for illegal recovery and harassment (during an illegal detention) in the last 66 years or as per available record

27) I want to know the no. of FIRs registered against Delhi Police officials for conducting illegal raids outside their jurisdiction area without making an entry in their Daily Dairy register.

a. I want to know the no. of Police officials who were punished for forceful illegal trespassing by breaking locks without making an entry in the Daily Dairy register of their own Police Station and the local police station.

28) In December 2012 an encounter was done by PS Rani Bagh officials in the jurisdiction of PS Model Town on some incorrect information. In this encounter a Constable named Ajay was shot by mistake and who was admitted in Max Hospital where his treatment was done. I had applied several RTIs and complaints in this matter. But till now I haven't been told even the FIR no. in this case. Therefore I want an explanation about this from Delhi Police Commissioner (the matter was also published in Navbharat Times)

I want the reply through E-mail on my E-mail ID given below or through a CD to avoid wastage of Govt. Paper and Deforestation. In the interest of Environment. I am ready to pay the charges of the CD-ROM or E-mail
