
I am to refer to your RTI application dated 02.06.2014, received on transfer through Cabinet Secretariat for providing information in respect of para no. 1 to 5 of your application.

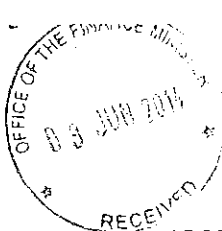
