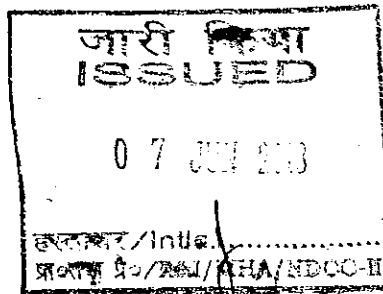

How many of these names have been approved by the PM/PMO?

2) In which year did the ministry of New and Renewable Energy (MNRE) come into existence? What was its cashier name? How much money / public funds have been spent by the ministry ever since its birth? What is its present budget? Will the Ministry provide a detailed account of its outlays and outcomes during the last ten years and a road map for the next ten years? Has it prepared a detailed white paper on this report?

3) Are the officers of this ministry involved in the preparation of the Clean Energy Mission (CEM) that was held in Delhi recently? Have the officers

① Please provide a copy of the report on Pricing of Natural Resources prepared by the Committee on Chairman Mr. Chopra of India headed by its Chairman Mr. Chopra. Has the P.M. received a copy of its recommendation? What were the details of terms of reference of this report Commissioned by Govt. of India?

② During his meeting with the C.M. of Punjab (Mr P.S. Badal <sup>deputy chief minister</sup>) on the subject of commencing the death sentence awarded to Bhullar <sup>did our P.M. Mr Man Mohan Singh</sup> open his mouth to give an assurance to Mr Badal that he (The P.M.) would sympathetically consider his plea <sup>Did the P.M. only listen without opening his mouth?</sup> plus there a written assurance <sup>plus any letter/note written to any authority in the light of what transpired in the meeting</sup>

③ Please provide a copy of detailed assurance given to the German Govt at the time of extradition of Bhullar to India that he (Bhullar) wouldn't be hanged.
