With reference to online RTI application dated 16.01.2014, filed by Ms. Ruhi Ojha, the applicant is informed that as per records available in the UTS-I & UTS-II, Rs. 50 Lakhs (Rupees Fifty Lakhs only) was sanctioned in each of the financial years 2009-10, 2010-11 & 2012-13 and Rs. 90 lakhs (Rupees Ninety Lakhs Only) in the financial year 2013-14 for training of probationers under the head:-

"2.70.00.109.02.0020-Other Administrative Expenses."


The complete head for the financial year 2013-14 is as follows:

"Grant No. 52-MHA:2070-Other Administrative Services (Major Head) 00.109-Intelligence Bureau (Minor Head) 02-Expenditure on training of probationers to Joint Service Cadre for UTs 02.00.20-Other Administrative Expenses for the Financial Year 2013-14."

For the Financial Year 2013-14, Budget Estimate of Rs. 1.00 Crore was allocated in the aforesaid head. After the mandatory 10% cut by the Finance Ministry, the budget allocation was reduced to Rs. 90 Lakhs (Rupees Ninety Lakhs Only). Already an amount of Rs. 59 Lakhs (Rupees Fifty Nine Lakhs Only) has been reimbursed to Delhi Government in the Financial Year 2013-14. The total bills amounting to Rs. 1, 20, 50,964/- (Rupees One Crore Twenty Lakhs Fifty Thousand Nine Hundred and Sixty Four Only) are pending.
