I am directed to refer to your online application under RTI dated 4th May, 2014 (Received by this CPIO on 16th May, 2014) and to inform that with reference to point No. 3 of your application, a sum of Rs. 30,32,000/- was released for the year 2010-11 for establishment of four Anti Human Trafficking Units and a sum of Rs. 22,74,000/- was released for the year 2011-12 for establishment of three Anti Human Trafficking Units. In addition to the above, a sum of Rs.1,40,000/- was also released to the State Government of West Bengal for assistance to police for rescue of victims of Human Trafficking, their food, shelter, travel etc.

2. As regards the other points of your RTI application, the same is transferred to Director (Finance), Ministry of Home Affairs, North Block, New Delhi under section 6(3) of the RTI Act, 2005 for further necessary action.
