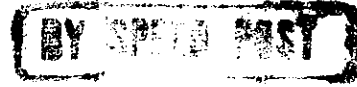

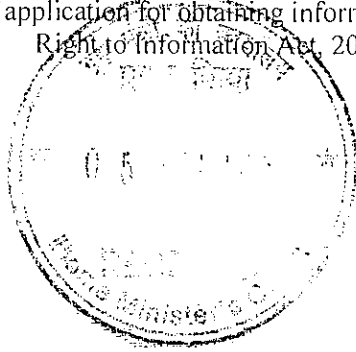

Please refer your RTI application dated 01.08.2013 submitted under the RTI Act, 2005, received on transfer from RTI Cell MHA on 19.08.13.

As per available information, IMD had issued general warnings for isolated heavy to very heavy rainfall/thundershowers on 15<sup>th</sup> and 16<sup>th</sup> June, 2013 in the State of Uttarakhand. Meteorological Centre, Dehradun issued local advisories in relation to the char dham yatra. The State Government issued advisories to all the concerned districts authorities. Announcements were made by Police personnel stationed at Kedarnath, Rambada and Gaurikund alerting general public. The forecasts of IMD have also been in the public domain through their website at www.imd.gov.in.

3. However, specific information asked under your application is related specific to the State Government of Uttarakhand, Ministry of Defence and India Meteorological Department. In view of the above, a copy of your RTI application is being transferred to them for providing information available with them, to you directly. You are requested to contact the CPIOs concerned for further information in this regard.
