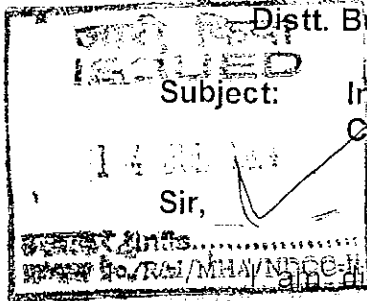

Subject: Information sought for under the RTI Act, 2005 by Rekha Rani Chowdhury.

Sir,

am directed to refer your application dated 24.3.2014 on the above mentioned subject and to say that you have sought the following information under RTI Act, 2005 as under:-

- i) Why I am not being paid Rs. 8000/- as SSS Pension from the beginning?
- ii) When shall I received the pension of Rs. 15000/- as per the notification of the Government.
- iii) When & how shall I received the entire sum of money as Arrears since 1.8.2005?

2. With reference to central Samman Pension, the dearness relief has been revised periodically in consultation with the Ministry of Finance.

3. Recently, this Ministry vide letter dated 8.11.2013 (copy enclosed) has granted another installment of Dearness Relief to various categories of freedom fighters and their eligible dependent under the S.S.S. Pension Scheme, 1980, @28% with effect from 1.8.2013. The total Dearness Relief payable to various categories of the freedom fighter and their eligible dependent w.e.f. 1.8.2013 would be 193%.

4. As per record available Smt. Radha Rani Chowdhury, spouse has been receiving dependent family pension in full under SSS Pension Scheme, 1980.
