This is Petition Under Section 6 of the Right to Information Act.

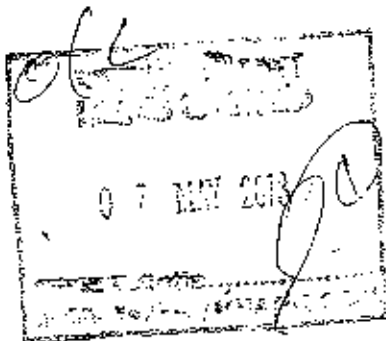
