I beg to state that the undersigned had sent an RTI application dated -01/04/2013 addressed to the CPIO, MHA(NE II) seeking for information as requested in my RTI petition containing in its seventh questions .However,I have received on 21/05/2013 a letter no.9/7/2013-NE-II(vol.II) Dated 09/05/2013 from Dr.M.C. Mehanathan,Joint secretary (NEII) & CPIO who mentioned in his letter out of the seventh questions as I made in the said petition, (ii),(iii),(iv),(Vi) & (Vii) is treated as "Nil" .Thus, only two question's (i) & (V) answers of 65 pages is available in his section.
