- 2. The number of persons below 18 years of age who were recruited/used by CPI (Maoist) is not available. 'Police' and 'Public Order' being state subjects, action with respect to maintenance of law and order lies primarily in the domain of the State Governments. The Central Government closely monitors the Left Wing Extremism (LWE) situation and supplements the efforts of the State Governments over a wide range of issues, both on the security and development fronts. These measures include deployment of Central Armed Police Forces, help to State Governments towards capacity building of State Forces and implementation of a wide range of development schemes in LWE affected States.
