

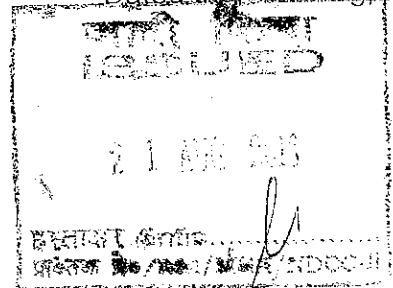

Sir,

Please refer to your RTI application dated 26.07.2013 submitted under the RTI Act, 2005, received on transfer from Prime Minister's Office on 12.08.13.

2. With regard to point No. 2 regarding information of disaster in Uttarakhand, it is informed that firstly we have received the information of disaster through telephonically.

3. With regard to point No.3 regarding action taken by the Central Government, In this regard, it is informed that the State Government concerned are primarily responsible for undertaking necessary relief and rescue measures in the wake of natural calamities. The Government of India supplements the efforts of the State Governments by extending financial and logistical support, wherever required. In the immediate aftermath of the natural disaster in Uttarakhand in June, all the concerned ministries of Government of India have created their support in resuce and relief efforts. However, Central Government have done the following relief and rescue works:-

- NDRF, ITBP and Armed Forces rescued over a lakh persons and rescued them to safer placed and all the pilgrims stranded at various places were ervacuated to safer places (as on 02.07.13). (However, it must be taken into cognisance that many persons would remain at Badrinath Ji, Gangotri and Yamunotri till the holy doors of respective dhams get closed for winter tll second week of November, 2013).
- NDRF depoyed 14 teams for the operation and rescued 9,502 persons as on 18.07.13.
- 38 dozers, 32 excavators, 33 JCBs and 3778 GP/Maz were deployed by Border Roads Organisation (BRO) to restore road connectivity in the affected area.
- In pursuance of announcement made by Hon'ble Prime Minister, Rs. 145 crore was released to the State from SDRF on 20.06.13. In addition, an amount of Rs. 250 crore has released from NDRF to the State on 19th July, 2013.
- The Central Government has sent about 80 doctors at the disposal of State Government, to assist them.

- The National Crisis Management Committee (NCMC), under chairmanship of Cabinet Secretary & The National Executive Committee (NEC) headed by Home Secretary has monitored the progress of rescue & relief operations in Uttarakhand.
4. Since the subject matter of your application is related specific to the State Government of Uttarakhand and Ministry of Defence. In view of this, a copy of your application is being transferred to the State Government of Uttarakhand and Ministry of Defence for providing information, if any, directly to you.
5. If you are not satisfied with this reply, you may prefer an appeal under Section 19(1) of the RTI Act, 2005 within thirty days from its receipt to
