Please refer to this Ministry's letter No 18015/19/2013-NM.IV dated 10.02.2014 in connection with your application dated 28.01.2014 seeking information under the RTI Act, 2005 regarding naxal attacks in Jharkhand.

2. Available information on point nos. (4) & (6) of the said application is given below:

Under the Security Related Expenditure (SRE) Scheme for the LWE affected States, the Central Government, inter-alia, reimburses the expenditure incurred by the State Governments for the ex-gratia payment to the family of victims of the naxal violence and for the expenditure incurred on Surrender and Rehabilitation of the surrendered LWE cadres. The fund released to the State Government of Jharkhand under the SRE Scheme after getting the audited reports which includes expenditure incurred on ex-gratia payment to the family of civilian / security forces killed in LWE violence, insurance of police personnel, training and operational needs of security forces, compensation to Left Wing Extremist cadres who surrender in accordance with the surrender and rehabilitation policy of the concerned State Government, community policing, security related infrastructure for village defence committees and publicity material during the year 2000 to 2013 is tabulated as below.


