Please refer to PMO's communication No. RTI/3272/2013-PMR dated 16.07.2013 under reference to your RTI application dated 11.07.2013 received in this office on 22.07.2013 through Deputy Secretary & CPIO (PMO), South Block, New Delhi - 110011.

2. As regards Point Nos. 1 to 3 of your application, it is informed that data of SFs, Civilians and Naxals killed is available since 1980 and data of public property destroyed by Naxals is available since 2006 and the information on these points is annexed.

3. As regards Point No. 7, it is informed that the Government of India is committed for solving the naxal problem by providing assistance to the State Governments in every manner possible, including providing Central Armed Police Forces (CAPFs) and sharing intelligence. In addition, the Central Government provides funds towards capacity building by States through a number of security related schemes. The Government of India has also launched a number of measures for the development of LWE affected areas. In a nutshell, the Government of India has a two pronged strategy to deal with LWE problems which includes **security measures** and **development measures**.

4. As regards point Nos. 4 & 5, your application is being transferred to the Director (NM-I), Director (ANO-II) & Deputy Secretary (NM-II) of NM Division and Director (VTV Section) of IS-II Division, and Ministry of Home Affairs, New Delhi

5. The appeal against this reply lies with Sh. M. A. Ganapathy, Joint Secretary (NM), Room No.193-A/1, North Block, Ministry of Home Affairs, New Delhi within 30 days of receipt of this reply.
