Point No. 01:- Appointment in DANICS against promotion quota vacancies is made on regular basis for which officers from feeder services, including DASS, are considered. There is no such provision of appointment of DASS officers in DANICS on ad-hoc basis.

Point No. 02:- There is no provision for appointment of Delhi Government Grade - I, DASS officers to the ~~post~~ cadre of DANICS on Ad-hoc basis.

Point No. 03:- The promotion and removal from service in respect of DANICS (regular basis) is governed by the CCS (CCA) Rules, 1965 and other instructions in force as amended from time to time by the DoP&T. The applicant is informed that induction & promotion in DANICS is governed by DANICS Rules, copy of which can be assessed from the website of the Ministry (www.mha.nic.in).

4. The name and designation along with address of Appellate Authority under RTI Act may be provided to whom I should approach if not satisfy with the information provided by goodself.


