Information under RTI Act, 2005–Disturbed Area Under AFSPA

With reference to above mentioned RTI application, part-wise replies are as under:-

- 1. As per Section 3 of the Arms Forces (Special Powers) Act, 1958 if, in relation to any State or Union territory to which this Act extends, the Governor of that State or the Administrator of that Union territory or the Central Government in either case, is of the opinion that the whole or any part of such State or Union territory, as the case may be, is in such a disturbed or dangerous condition that the use of armed forces in aid of the civil power is necessary, the Governor of that State or the Administrator of that Union territory or the Central Government, as the case may be, may, by notification in the Official Gazette, declare the whole or such part of such state or Union territory to be a disturbed area.
- 2. Violence became the order of the day in the North-East and many insurgent groups with secessionist constitution started operating using violent means to achieve their objective. They threw a challenge to the sovereignty and integrity of the Nation with cross-border support. Hence, maintenance of peace and public order became beyond the capacity of the State Govts. Hence, in order to aid the civil power, deployment of armed forces became necessary. Hence, Arms Forces (Special Powers) was enacted.

The violence level on the ground is periodically reviewed and only where called for, declaration of disturbed area is issued. As regards applicability of the Act in Kashmir, the information may be obtained from CPIO, Kashmir Division of MHA. And as regards non-applicability of Arms Forces (Special Powers) in Naxal affected areas, CPIO, Naxal Management (NM) Division of MHA may be approached for information.

3. As stated against point 2 above, violence level in the North East is periodically reviewed and only where called for, declaration of disturbed area is issued and only in those areas, provision of Arms Forces (Special Posers) will be applicable.
