In the ministry of MHA under Aizwal set up one unit was set up in feb 2013. All the existing under the same set up were being provided with ration allowance for the said period i.e. feb 2013 to feb 2014. the new unit was not having presanction for the same and in the subsequent year the allowance was approved for all the units effective form 1st march 2014.

Information Sought:

Now is it justified to not provide the ration allowance to staff posted at new unit for the said period under Aizwal set up when all the other units were being provided with the same. It might be noted that the new unit was sanctioned the said allowance from the period when renewal for all the set up was due i.e. march 2014.

Clear instructions/guidance for the same is requested as the department is putting the onus on the ministry of finance for the non payment of the allowance for the said period (1st feb 2013 to 28th feb

2014).
