The State Governments specifically deal with various issues related to LWE activities in the States. The Central Government monitors the situation closely and supplements the efforts of the State Governments over a wide range of security and development related schemes.

2.2 These include providing Central Armed Police Forces (CAPFs) and Commando Battalions for Resolute Action (CoBRA); sanction of India Reserve (IR) battalions; setting up of Counter Insurgency and Anti Terrorist (CIAT) schools; modernization and upgradation of the State Police and their Intelligence apparatus under the Scheme for Modernization of State Police Forces (MPF scheme); reimbursement of security related expenditure under the Security Related Expenditure (SRE) Scheme; filling up critical infrastructure gaps under the Scheme for Special Infrastructure in Left Wing Extremism affected States; construction/strengthening of fortified police stations under the Scheme for Construction/ Strengthening of 400 Fortified Police Stations in LWE affected districts; providing helicopters for Anti-naxal operations; assistance in training of State Police through Ministry of Defence, Central Police Organisations and Bureau of Police Research and Development; sharing of Intelligence; facilitating inter-state

coordinated joint operations; assistance in community policing and civic actions; and assistance in development works through a wide range of schemes of different Central Ministries.

- 2.3 In the development arena, in addition to various development programmes/ flagship schemes being implemented throughout the country, the Planning Commission is implementing an Integrated Action Plan (IAP)/ Additional Central Assistance (ACA) in 88 Selected Tribal and Backward Districts, inter alia, including 76 LWE affected districts, for accelerated development of the affected areas.
- 2.4 The Government of India believes that continuing with the present policy in the areas of security, development, governance and ensuring entitlements of tribals and other marginalized communities will significantly weaken the LWE insurgency and its support base.
