Subject : Application seeking information under the Right to Information Act, 2005.

Sir,

I am to refer to your application No. GC/RTI/3209 dated 21.11.2013 addressed to CPIO, Ministry of Home Affairs, North Block, New Delhi-1. Under Secretary, RTI Section vide their O.M. No.A 43020/01/2013-RTI dated 16.12.2013 has transferred it to the undersigned CPIO (received on 23.01.2014) seeking various information under the Right to Information Act, 2005.

2. In this regard, point wise reply is given as under:

Point No.1: Since the information is more than 90 years old, the same is not readily available with this Ministry. This information may be more closely related / available with the following Ministries/ Department/ organisations:

- i. Ministry of Defence: Because the most of the provisions of the Act are meant to protect the information/ buildings/ installations/ secrets of NAVY/ARMY/AIR FORCE etc.
- ii. Ministry of Law & Justice: because they are depository of all Acts/ Rules/ Notifications etc.
- iii. National Archives of India: because all the old records of the Ministries/ Departments which have historical importance is stored/ restored by them.
- iv. Government of India Press: Because all the Notifications published by them in the Gazette of India and may have the copies of these notifications in their record.
- v. Central Secretariat Library: because they have in possession of official records such as copies of Notifications/ Acts/ Rules etc. of the Ministries/ Departments.

Point No.2 & 3: These points seems to be more closely related to the Ministry of Law & Justice.

3. In view of the above, the aforesaid application dated 21.11.2013 is hereby transferred under Section 6 (3) of the RTI Act, 2005 to concerned CPIO as mentioned in para 2 above with the request to provide the information directly to the applicant with an endorsement to the undersigned CPIO. If the information is not available with them, the application may please be transferred to the concerned CPIO under intimation to the applicant.

4. Under Section 19(1) of the Right to Information Act, 2005, an appeal can be filed within 30 days from the date of receipt of the reply, before the first Appellate Authority, whose particulars are given below :

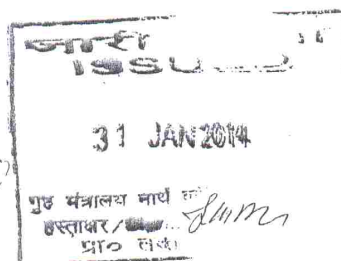

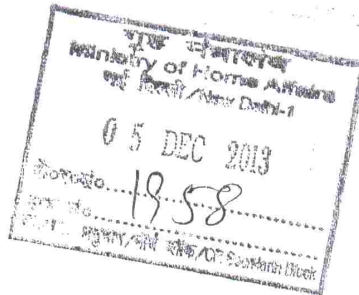
