
Sir,

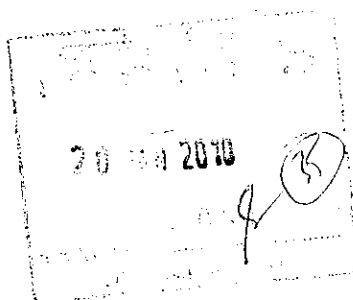

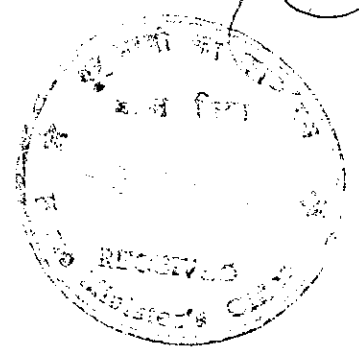
