Please refer to this Ministry's communication No. I-21023/45/2013-IPS.III dated 15.10.2013 under reference to your RTI application dated 07.08.2013 and received in this office on 17.10.2013 through Director (Police) & CPIO, Ministry of Home Affairs, North Block, New Delhi - 110001.

- 2. Information sought in point no. 4 C & D (year-wise data of SFs and Civilians killed for last 10 years) is annexed.
- 3. As regards point no. 4 F (steps being taken to check naxalism), it is informed that 'Police' and 'Public Order' being State subjects, action with respect to maintenance of law and order lies primarily in the domain of the State Governments concerned. However, the Central Government supplements the efforts of the State Government through various ways and means. Following steps have been/are being taken by the Central Government to check naxalism:
- (i) Deployment of Central Armed Police Forces (CAPFs): A total of 90 battalions of CAPFs and 01 India Reserve Naga battalion are currently deployed for assisting the State Police in States of Andhra Pradesh, Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Maharashtra, Odisha, Uttar Pradesh and West Bengal. Besides, 09 Battalions of Commando Battalions for Resolute Action (CoBRA) have also been deployed for anti-naxal operation.
- (ii) India Reserve Battalions/SIRB: The Left Wing Extremism affected States have been sanctioned India Reserve (IR) battalions mainly to strengthen security apparatus at their level as also to enable the States to provide gainful employment to youth, particularly in the LWE affected areas.
- (iii) Construction of Fortified Police Stations: A scheme is being implemented namely 'Construction/ Strengthening of Fortified Police Station' in the LWE affected States. Under this scheme 400 PSs would be constructed in the 9 LWE affected States.
- (iv) Setting up of Counter Insurgency and Anti Terrorist (CIAT) Schools: In order to strengthen the training inputs in the States affected by insurgency and terrorism, during the 11th Plan period, a Centrally Sponsored scheme was approved for establishment of 20 CIAT Schools, 04 each in the States of Assam, Bihar, Chhattisgarh, Jharkhand and Odisha.

- (v) Creation of the Unified Command: Following direction of the Central Government, the States of Chhattisgarh, Jharkhand and Odisha have constituted a Unified Command to carry out carefully planned anti naxal operations. The State of West Bengal had already constituted the Unified Command.
- 4. As regards point no. 4 E (amount of ex gratia given), your application is being transferred to the Director (VTV Section) of IS-II Division and Shri Rambir Singh, Director (NM-I) & CPIO, Ministry of Home Affairs, New Delhi.
