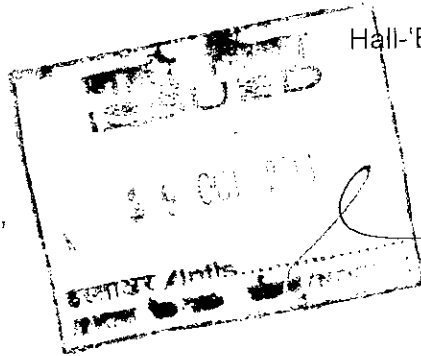

2. It is mentioned that in the wake of natural disasters, the State Government are primarily responsible for undertaking necessary rescue and relief measures in the wake of natural calamity. The distribution of relief on ground is the responsibility of the State Government concerned in the wake of natural calamities in accordance with the magnitude of the situation.

3. In view of this, it is informed that the village-wise/district wise relief distribution on the ground is not maintained in the Ministry of Home Affairs, the concerned State Government may be able to submit the requisite information, since undertaking rescue & relief operation on ground is the responsibility of the State Government concerned. However, your application is being sent to the State Government of Bihar for their appropriate action.

4. If you are not satisfied with this reply, you may prefer an appeal under Section 19(1) of the RTI Act, 2005 within thirty days from its receipt to
