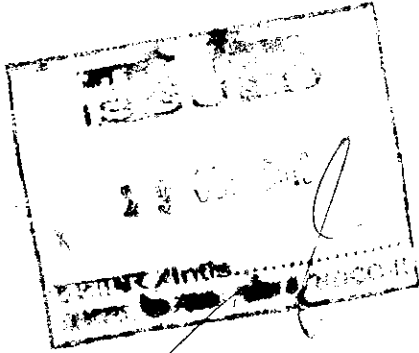

Sir,

Please refer to your RTI application dated 21.10.2013 submitted online under the RTI Act, 2005, received by this Section on 22.10.2013.

2. With regard to point No.1, regarding allocation of budget to various states towards Disaster Management, it is to inform that, Section 48 (1) of Disaster Management Act, 2005 provides for constitution of State Disaster Response Fund (SDRF) by the Governments. This Ministry has issued the guidelines on constitution administration of the SDRF and NDRF on 28<sup>th</sup> September, 2010, which is uploaded on the website of this Ministry [www.ndmindia.in](http://www.ndmindia.in).

3. It is mentioned that, budget provision of SDRF/NDRF is managed and administered by the Ministry of Finance. The State Government concerned is required to undertake rescue & relief operation of immediate nature, in all the areas affected by the natural calamity including floods, earthquake. No calamity wise allocation is made to State. Similarly, allocation in the SDRF of the State is made for entire state for all notified calamities, and it is for the State Government concerned to allocate the funds from SDRF to affected districts, in the wake of a natural calamity including flood, earthquake. The expenditure from relief fund is to be incurred in accordance with the approved Items & Norms. Accordingly, the concerned State Government may be able to submit the information in the matter, since, undertaking the relief operation on the ground is the responsibility of the State Government concerned. However, a statement showing state wise allocation of State Disaster Response Fund (SDRF) for the period 2010-15 is given below:-
