You are requested to please give following requested information duly verified from NIDM and Ministry office records, under RTI Act 2005 provisions:

1. (a) Is it true that Dr. K J Ananda Kumhar working on deputation from Central Ground Water Board for the last 4 years at NIDM? What is the additional perks/allowances in % he is availing besides his salary, at NIDM?

(1.B) Is it true that Dr. KJ Anandha Kumar was appointed on deputation on 18.9.2009 at NIDM as Associate Professor despite of the fact that Dr Kumar didn't fulfil minimum eligibility criteria of screening his/her application for the post at NIDM as per the then recruitment rules of NIDM or UGC / IIPA criteria of selection of Associate Professor?

(1.B.1) How many years of teaching/training experience and experience as Assistant Professor he had at the time of his application to NIDM?

(1.B.2) What was his grade pay/scale at the date he submitted his application to CGWB to be forwarded to NIDM, and in the copy of application received at NIDM?

(1.B.3) What is the subject of his masters degree? Did he possess a masters degree in Hydrology/Meteorology or Agriculture Science?

(1.C) Is it also true that the process of selection and appointment of Dr. KJ Ananda Kumhar was faulty as there were only two candidates appeared in the interview? (1.C.a) what was the pay scale/grade pay of Mr Anandha Kumar in his own department/CGWB mentioned in his application form submitted to NIDM for post of Associate Professor?

(1.D) Is it also true that Dr K J Ananda Kumhar, who is a faculty member on deputation, has been given charge of NIDM administration and also appointed as In-charge Executive Director of the institute from time to time? Please give details of such periods with specific dates, and the charge giving authority's name/designation.

(1.E) Did Dr. Kumhar obtained him/her Ph.D. degree with due permission of the Ground Water Board?

(1.G) Is it true that Dr Kumhar is managing extra-ordinary extension of his tenure at NIDM as he is benefitted greatly in terms of financial earnings in form of training allowances and facilities like official car (for coming to office and going home), AC and laptop, and financial powers.

(1.H). Is it true that Dr. Kumhar has been given charge of NIDM' s administration in absence of the Executive Director despite of a Joint Secretary level Professor being available at the institute? Give reason as per office record (reference, file no, page, date ordering authority).

2. (A) How many faculty members of NIDM have been deputed to foreign training on the expenses of Govt. of India/NIDM in the last 5 years. Give list with details of name/courses/dates/country.

(2.B) How many faculty members were invited by academic/UN agencies and institutes outside India for academic purposes with funding sponsorship in the last 5 years. Give list with name/event/inviting agency/country/dates.

(2.C) How many faculty members have been send for faculty development programmes during last 5 years (in India and outside), pl give list and date/year/name of courses.


(2.D) Give the list of faculty members in-charge of international projects in last 5 years (name, project, dates/duration, agency, funding, date of completion).
