- 2. In this regard, the point-wise reply is as under:
  - (1) With reference to point No.(2) of your application, it is stated that this unit is concerned only with provision of security cover to individuals based on assessment of threat.
  - (2) With regard to point No.(3) of your application, it is stated that the number of categorized protectees varies from time to time based on the threat assessment made by the Central Security Agencies. However, as on date, there are 62 number of Z category protectees in the Central list.
  - (3) Query on Point No.(8) of your application does not come under the definition of 'Information' under the RTI Act-2005. However, as indicated above, security to an individual is provided on the basis of threat assessment carried out by security agencies.
